Petitioner's Request for Refund

Petitioner Supercell Oy ("Petitioner") respectfully requests a refund of the post-institution fees paid by Petitioner in the instant proceeding.

On December 9, 2020, Supercell Oy ("Supercell") filed a Petition for Post Grant Review of U.S. Patent No. 10,583,362 requesting review of twenty-seven claims. (Paper 2) Petitioner paid a fee of \$55,185, including: (i) \$20,000 for a post grant review request fee for up to twenty (20) claims; (ii) \$27,500 for a post grant review post-institution fee for up to twenty (20) claims; (iii) \$3,325 for a post grant review of each claim in excess of twenty claims (\$475 for seven additional claims in excess of 20); and (iv) \$7,350 for post grant review post-institution request for each claim in excess of twenty claims (\$1,050 for seven additional claims in excess of 20).

On May 19, 2021, the Patent Trial and Appeal Board ("the Board") issued a decision denying institution of post-grant review on all challenged claims. (Paper 11)

In accordance with 37 C.F.R. § 42.15(b)(2), Petitioner respectfully requests a refund of Petitioner's paid post-institution fees in the amount of \$34,850 credited to Petitioner's USPTO Deposit Account (No. 19-2555).
