

[57] ABSTRACT

A method for generating electric power, such as at, or close to, natural gas fields. The method includes conditioning natural gas containing C_{3+} hydrocarbons and/or acid gas by means of a membrane separation step. This step creates a leaner, sweeter, drier gas, which is then used as combustion fuel to run a turbine, which is in turn used for power generation.








