Ameranth does not agree to a second extension to the defendants' deadline to respond to the complaint (Case No. 2:23-cv-02165), after Ameranth not only agreed to extend the first deadline, but also agreed to a longer extension than was specified in LCvR 7. The parties are different in this case compared to the earlier case, there are new and different venue factors, and the patents and patent claims are different as well, along with there being new DoorDash patents that copied Ameranth's earlier innovations too. Further, the two new patents have very limited patent life remaining, and Ameranth is entitled to timely enforce them during their validity period. Consequently, Ameranth seeks to promptly move forward with this litigation.
