RESPONSE TO OFFICE ACTION OF OCTOBER 3, 2005

This is in response to the Office Action of October 3, 2005, in which the Trademark Attorney made final her refusal to grant the subject application on the grounds that such registration would be contrary to Section 2(d) of the Trademark Act of 1946 (as amended), 15 U.S.C. § 1052(d). For the reasons set forth below, Applicant respectfully requests the Trademark Attorney to reconsider her refusal and to pass the subject application for publication.

For years, Applicant, including predecessors-in-interests, have sold hair care preparations under the mark ION. Applicant owns multiple registrations for its ION mark, including the following:

(i) Registration Number 1,320,267, filed May 13, 1981, and registered February 19, 1985, for "[p]ersonal [d]etergent for [u]se on the [h]air and [b]ody, [h]air [m]oisturizing
[t]reatment, [h]air [r]econstructor [t]reatment, [h]air [f]inishing [t]reatment, [h]air [p]ermanent
[w]aving [t]reatment, and [h]air [f]ixative" (emphasis added); and,

(ii) Registration Number 3,071,641, filed March 2, 2002 and registered March 21,
2006, for "[h]air care preparations [and] hair colorants" (emphasis added).

Applicant now seeks registration of the mark ION for "hair bleaching preparations" (hereinafter "Subject Mark"). "Hair bleaching preparations" constitute both a "hair care preparation" and a "hair colorant." *See, e.g.*, Exhibits 1 - 3 (attached hereto).

The Trademark Attorney has cited Registration Number 2,902,821 (hereinafter "Cited Registration") for the below depicted mark which is registered for "[c]osmetics, namely, cleansing beauty oil, cleansing beauty gel, beauty emulsion, face cream, beauty mask gel, beauty essence oil for personal use, eye care cream, pure essential oil for personal use, massage cream, facial mask, compacts, perfume, skin cleansing cream, *hair waving lotion, hair dye*, skin cleansing lotion and essential oils for personal use" (emphasis added):



The Cited Registration was filed May 1, 2003, registered November 16, 2004, and claims a Section 44 priority date of April 18, 2003.

As is clear from the foregoing, Applicant, not the owner of the Cited Registration, have clear priority (including priority of registration) in the mark ION for *all* hair care preparations. Furthermore, even with respect to the specific hair care preparations referenced in the Cited Registration, Applicant has clear priority, including, *inter alia*, hair permanent waving treatment *vis-à-vis* hair waving lotion, and hair colorant *vis-à-vis* hair dye. Under such circumstances, Applicant respectfully suggests that the Section 2(d) refusal is inappropriate.

The Trademark Attorney cited the well established authority that precedent is of little value in deciding the issue of likelihood of confusion, and that each such case must be

determined upon its own unique facts. Applicant, of course, does not contest such authority. However, Applicant is not relying upon the prior decisions of the Patent and Trademark Office, either allowing the Cited Registration or Applicant's Registration Number 3,071,641, as establishing the absence of likelihood of confusion. Rather, based upon the unique facts presented herein, namely Applicant's clear priority of use and registration rights for ION for the goods at issue, Applicant argues that the Section 2(d) refusal is inappropriate.

For the reasons set forth above and in the remainder of the record presented in support of the subject application, Applicant respectfully request the Trademark Attorney to reconsider her refusal and to pass the subject application for publication.
