## Notice of Appeal

Notice is hereby given that ALLTRANZ INC. appeals to the Trademark Trial and Appeal Board the refusal to register the mark depicted in Application Serial No. 78947809.

Applicant has filed a request for reconsideration of the refusal to register, and requests suspension of the appeal pending consideration of the request by the Examining Attorney.

The refusal to register has been appealed as to the following classes of goods/services:

- Class 003.  
Appealed goods and services in the class: Cosmetic products, namely, skin creams, gels, ointments, lotions, masks, moisturizers, patches, anti-wrinkle and anti-aging preparations
- Class 005.  
Appealed goods and services in the class: Pharmaceutical preparations, both prescription and over-the-counter, for use in connection with humans and animals, namely, cannabinoids, prodrugs, opioid agonists, opioid antagonists, opioid agonist-antagonists, allergy preparations, analgesics, anti-inflammatory, anti-irritants, anti-allergenic, antibiotics, antidiabetics, antidiarrheals, antiendotoxin antibodies, antifungal preparations, antihypertensives, antihistamines, antiarthritic preparations, anthelmintics, cardiovascular agents, dermatologic agents, diuretics, laxatives, pediculicides, preparations for treating nausea and vertigo, preparations for treating pain, sleep aids, stimulants, topical penetration enhancers for drug delivery through the skin and mucous membranes, microneedles for use in enhancing drug delivery through the skin, tranquilizers and psychotherapeutic preparations, vitamins; medicated skin care preparations, namely, medicated skin creams, gels, ointments, lotions, suspensions, solutions, matrix type and reservoir type transdermal delivery systems, masks, dermatologicals; pharmaceutical products for the treatment of pain, addiction, substance abuse, muscle spasms, treatment of alcoholism, treatment of neurodegeneration, gynecological and gastroenterology conditions, anal fissures, hemorrhoids, hormonal therapy, hormonal and steroidal deficiencies, hypogonadism, sexual dysfunction, skin and mucous membrane diseases; veterinary products, namely, feed supplements, antibiotics, derivatives thereof, and vitamins, either alone or in combination; pharmaceutical technology to modify existing chemical entities to produce new pharmaceutical products for the treatment of diseases involving the central nervous system
- Class 010.  
Appealed goods and services in the class: Drug delivery systems
