REQUEST FOR RECONSIDERATION DENIED

The Office has reassigned this application to the undersigned trademark examining attorney.

Applicant is requesting reconsideration of a final refusal issued/mailed October 8, 2008.

After careful consideration of the law and facts of the case, the examining attorney must deny the request for reconsideration and adhere to the final action as written since no new facts or reasons have been presented that are significant and compelling with regard to the point at issue.

Applicant has amended its recitation of services by deleting its retail store and wholesale distributorship services, leaving only "On-line retail store services featuring vitamins, minerals, dietary supplements, nutritional supplements." This amendment is not sufficient to obviate the likelihood of confusion because the attached evidence indicates that registrant sells both vitamins and dietary supplements along with analgesics and related products. See attached evidence from Standard and Poor's and Yahoo Finance. Further, the evidence from GNC, CVS, and Walmart demonstrates that these items are sold both on-line and through terrestrial retail stores. See attached evidence. Therefore, the mere deletion of the retail store services and the wholesale distributorship services featuring these items is not sufficient to render avoid the likelihood of confusion.

Accordingly, applicant's request for reconsideration is *denied*. The time for appeal runs from the date the final action was issued/mailed. 37 C.F.R. Section 2.64(b); TMEP Section 715.03(c). If applicant has already filed a timely notice of appeal, the application will be forwarded to the Trademark Trial and Appeal Board (TTAB).
