## Notice of Appeal

Notice is hereby given that Natbio Pty. Ltd. appeals to the Trademark Trial and Appeal Board the refusal to register the mark depicted in Application Serial No. 79032320.

Applicant has filed a request for reconsideration of the refusal to register, and requests suspension of the appeal pending consideration of the request by the Examining Attorney.

The refusal to register has been appealed as to the following classes of goods/services:

- Class 001.  
All goods and services in the class are appealed, namely: Chemicals used in industry and science; chemicals for use in agriculture, horticulture and forestry, namely, chemical preparations for the treatment of cereal grains, seeds and other plant material; chemical reagents namely chemical reagents for non-medical purposes, chemical reagents for use in scientific apparatus for chemical or biological analysis, in International Class 1
- Class 003.  
All goods and services in the class are appealed, namely: Cosmetics, cosmetic preparations, namely, preparations for body care; moisturizers, namely, skin moisturizers, skin care preparations, namely, medicated skin care preparations; soaps, namely, antibacterial soap; hair lotions, in International Class 3
- Class 005.  
All goods and services in the class are appealed, namely: Pharmaceutical preparations for the treatment of viral, bacterial and parasitic diseases, cancer, food allergies and intolerances; reagents for medical or veterinary use, namely, anti-inflammatory preparations; preparations for easing joint and muscular pain, herbal and natural remedies namely, herbal supplements, herbal teas for medical purposes; dietetic substances namely dietary supplements, food supplements; animal feed supplements; food additives, namely, food additives or ingredients to assist in removing or reducing intolerance and allergies to food; nutritional supplements, namely, preparations for aiding in digestion, all the aforesaid goods being for human or animal use; medicated skin care preparations in International Class 5
- Class 030.  
All goods and services in the class are appealed, namely: Sauces, marinades, meat and seafood tenderizers, flour; preparations made from cereal, namely, breakfast cereals, cereal based snack foods, bread products, yeast products, pastry products, cakes, donuts, biscuits, cookies; pasta, confectionery, namely, candies, gum sweets, pastes and spreads, tea, spices in International Class 30
