This letter responds to the applicant's communication filed on January 31, 2013.

The identification of goods/recitation of services is acceptable.

Regarding Applicant's arguments against the refusal to register the mark under Trademark Act Section 2(d), 15 U.S.C. Section 1052(d), the examining attorney has considered the applicant's arguments carefully but has found them unpersuasive. For the reasons below, the refusal under Section 2(d) is maintained and made FINAL.

Registration was refused under Trademark Act Section 2(d), 15 U.S.C. Section 1052(d), because the mark for which registration is sought so resembles the mark shown in U.S. Registration Nos. 3847218 and 3730781 as to be likely, when used in connection with the identified goods and services, as to cause confusion, or to cause mistake, or to deceive.

Applicant applied to register the mark GO FOR IT and design for, in pertinent part, "Pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" "Food concentrates primarily made of protein for use as a foodstuff for human consumption fortified with vitamins, minerals and amino acids; protein based nutrient dense, high calorie energy bars; high protein based nutrient dense snack bars; protein based, nutrient dense carbohydrate snack bars; dietetic, energy-boosting, protein-added and restorative foods, not for medical use, namely highly concentrated protein in gel form for use as a foodstuff for human consumption" "Wholesale store services featuring, pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" "retail store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" "on-line wholesale store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" "on-line retail store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments."

The registered marks are GO FOR IT! SPORTS and design for, in pertinent part, "Retail store and online retail store services featuring food supplements" and GO FOR IT! SPORTS TRAIN HARD RACE FAST and design for, in pertinent part, "Retail store and online retail store services featuring food supplements."

In a likelihood of confusion determination, the marks are compared for similarities in their appearance, sound, meaning or connotation and commercial impression. *In re E. I. du Pont de Nemours & Co.*, 476 F.2d 1357, 1361, 177 USPQ 563, 567 (C.C.P.A. 1973); TMEP §1207.01(b). Similarity in any one of these elements may be sufficient to find a likelihood of confusion. *In re White Swan Ltd.*, 8 USPQ2d 1534, 1535 (TTAB 1988); *In re Lamson Oil Co.*, 6 USPQ2d 1041, 1043 (TTAB 1987); *see* TMEP §1207.01(b).

The applicant's mark is GO FOR IT! and design and the registrants' marks are and GO FOR IT! SPORTS and design and GO FOR IT! SPORTS TRAIN HARD RACE FAST and design. The marks of

the parties are similar in sound, appearance and meaning. The dominant part of each party's mark is the word "go for it." Therefore, the similarities in the elements that exist are sufficient to find a likelihood of confusion.

The goods and/or services of the parties need not be identical or directly competitive to find a likelihood of confusion. *See Safety-Kleen Corp. v. Dresser Indus., Inc.*, 518 F.2d 1399, 1404, 186 USPQ 476, 480 (C.C.P.A. 1975); TMEP §1207.01(a)(i). Rather, they need only be related in some manner, or the conditions surrounding their marketing are such that they would be encountered by the same purchasers under circumstances that would give rise to the mistaken belief that the goods and/or services come from a common source. *In re Total Quality Group, Inc.*, 51 USPQ2d 1474, 1476 (TTAB 1999); TMEP §1207.01(a)(i); *see, e.g., On-line Careline Inc. v. Am. Online Inc.*, 229 F.3d 1080, 1086-87, 56 USPQ2d 1471, 1475-76 (Fed. Cir. 2000); *In re Martin's Famous Pastry Shoppe, Inc.*, 748 F.2d 1565, 1566-68, 223 USPQ 1289, 1290 (Fed. Cir. 1984).

The applicant's goods and services are, in pertinent part, "Pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments," "Food concentrates primarily made of protein for use as a foodstuff for human consumption fortified with vitamins, minerals and amino acids; protein based nutrient dense, high calorie energy bars; high protein based nutrient dense snack bars; protein based, nutrient dense carbohydrate snack bars; dietetic, energy-boosting, protein-added and restorative foods, not for medical use, namely highly concentrated protein in gel form for use as a foodstuff for human consumption" "Wholesale store services featuring, pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" "retail store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" "on-line wholesale store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" "on-line retail store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" and the registrant's goods are in pertinent part, "Retail store and online retail store services featuring food supplements." The examining attorney encloses evidence and prior registrations showing "Pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments," "Food concentrates primarily made of protein for use as a foodstuff for human consumption fortified with vitamins, minerals and amino acids; protein based nutrient dense, high calorie energy bars; high protein based nutrient dense snack bars; protein based, nutrient dense carbohydrate snack bars; dietetic, energy-boosting, protein-added and restorative foods, not for medical use, namely highly concentrated protein in gel form for use as a foodstuff for human consumption" "Wholesale store services featuring, pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies" "retail store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies" "on-line wholesale store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies" "on-line retail store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies" and "Retail store and online retail store services featuring food supplements" all offered by the same entities. The conditions surrounding the marketing of the goods may be such that they could be encountered by the same purchasers under circumstances that would give rise to the mistaken belief that the goods and services come from a common source.

Because of the similarities between the marks and the goods and services of the parties, a likelihood of confusion is created.

For the foregoing reasons, the refusal to register the mark under Trademark Act Section 2(d) is continued and made FINAL.

Applicant must respond within six months of the date of issuance of this final Office action or the following goods and/or services to which the final refusal(s) and/or requirement(s) apply will be **deleted** from the application by Examiner's Amendment: Pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies; pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" "Food concentrates primarily made of protein for use as a foodstuff for human consumption fortified with vitamins, minerals and amino acids; protein based nutrient dense, high calorie energy bars; high protein based nutrient dense snack bars; protein based, nutrient dense carbohydrate snack bars; dietetic, energy-boosting, protein-added and restorative foods, not for medical use, namely highly concentrated protein in gel form for use as a foodstuff for human consumption; "Wholesale store services featuring, pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" "retail store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" "on-line wholesale store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments" "on-line retail store services featuring pharmaceutical preparations for the treatment of obesity, constipation, hormonal imbalances and enzyme deficiencies, pharmaceutical preparations for alleviating pain, therapeutic pain-relief ointments." 37 C.F.R. §2.65(a); *see* 15 U.S.C. §1062(b).

The application will then proceed for the following goods and services and classes: 16, 32 and Wholesale store services, retail store services, on-line wholesale store services and online-retail store services featuring printed matter, namely, calendars, nonalcoholic beverages, namely, soft drinks, alcohol-free aperitifs, non-alcoholic fruit extracts used in the preparation of beverages, isotonic beverages, aromatized beverages based on fruit, protein, cordial, sugar and other fluid nutrients, namely, protein drinks for use as a food fillers and not for use as a meal replacement.

Applicant may respond by providing one or both of the following:

- (1) A response that fully satisfies all outstanding requirements;
- (2) An appeal to the Trademark Trial and Appeal Board, with the appeal fee of \$100 per class.
