Interested in patent law? Many firms claim to do patent work but here are the firms with the registered patent attorneys and agents to back up that claim. [Finnegan Henderson](#) wins the top honors in with 276 registered attorneys and agents.

Only 20% of the patent attorneys and agents in the U.S. work for these 100 firms. About a third of the remaining agents and attorneys are not affiliated with any firm or company, working as solo practioners. The remainder, about 55% of all patent attorney and agents, work for corporations, government agencies or smaller firms.
