Pursuant to 37 C.F.R. § 2.117, Opposer Wet Willie's, Inc. ("Opposer") hereby files its Motion to Suspend for Civil Action, and shows the Board as follows:

On August 18, 2005, Opposer's affiliated entities, Wet Willie's Management Corp. and South Beach Wet Willie's, Inc., filed a civil action against Applicant for trademark infringement, dilution, and unfair competition in the United States District Court for the Southern District of Florida, Miami Division (Case No. 05-CV-22300). A copy of the complaint is attached hereto. Opposer submits that the Federal Court Complaint has a direct bearing on this proceeding, as Opposer and its affiliated entities seek damages and injunctive arising from Applicant's use of the mark WET WILLY'S – the mark at issue in this proceeding.
