On September 15, 2014, applicant filed, with opposer's written consent, a proposed amendment to its involved application Serial No. 85401846, the subject of Opposition No. 91205184, and application Serial No. 85401851, the subject of Opposition No. 91205350. By the proposed amendment, for each application, applicant seeks to change the identification of goods in International Class 3 for Serial No. 85401846 **from:**

"After sun creams; After-sun lotions; Cosmetic creams for skin care; Cosmetic nourishing creams; Cosmetic preparations against sunburn; Facial creams; Moisturizing preparations for the skin; Non-medicated ointments for the prevention and treatment of sunburn; Non-medicated skin care preparations, namely, creams, lotions, gels, ointments and liquids."

**to:**

"After sun creams; After-sun lotions; Cosmetic preparations against sunburn; Facial creams; Moisturizing preparations for the skin; Non-medicated ointments for the prevention and treatment of sunburn; all of the foregoing excluding nonmedicated lip care preparations and products for treating eczema, psoriasis, diabetic skin conditions, or cracked dry skin."

Similarly, applicant seeks to change the identification of goods in Class 5 for Serial No. 85401851 **from:**

“Anti-inflammatory ointments; Medicated lotions for face and body; Medicated skin preparation for use in treating sunburns, facial wrinkles, dry skin, burns, rashes and wounds; Medicated sun block; Medicated sun care preparations; Medicated sun screen; Pharmaceutical preparations for wounds; Pharmaceutical skin lotions.”

**to:**

“Anti-inflammatory ointments; Medicated skin preparation for use in treating sunburns, facial wrinkles, burns, rashes and wounds; Medicated sun block; Medicated sun care preparations; Medicated sun screen; all of the foregoing excluding medicated lip care preparations, antiseptics, and products for treating eczema, psoriasis, diabetic skin conditions, or cracked dry skin.”

The proposed amendments are limiting in nature as required by Trademark Rule 2.71(a). Because opposer consents thereto, the amendments are **APPROVED** and entered. *See* Trademark Rule 2.133(a).

If the foregoing amendments resolve these consolidated proceedings, opposer should withdraw the notices of opposition within **THIRTY (30) DAYS** from the mailing date of this order, failing which the consolidated proceedings will go forward on the applications as amended. *See* Trademark Rule 2.106(c). Proceedings are otherwise **SUSPENDED**.
