OPPOSER'S MOTION FOR SUSPENSION PENDING CIVIL LITIGATION

Pursuant to TBMP Section 510.02, Opposer Karen Becker Edson ("Opposer") hereby requests that these proceedings be suspended by the Board pending the outcome of Case No. 2:22-cv-00778-TC, filed by Opposer in the United States District Court for the District of Utah. A copy of the Complaint is attached as Exhibit 1.

TBMP Section 510.02(a) states:

Whenever it comes to the attention of the Board that a party or parties to a case pending before it are involved in a civil action that may have a bearing on the Board case, proceedings before the Board may be suspended until final determination of the civil action.

The civil action alleges Applicant Lotus Craft, LLC ("Applicant") has engaged in unfair competition, deceptive trade practices, and misappropriation of right of publicity; and, among other things, seeks relief by requesting that the Applicant be ordered to abandon any existing applications to register all BECKER-formative trademarks, including the application at issue in this proceeding. As such, the relief sought in the civil action may ultimately decide the issue before the Board in this proceeding

Accordingly, Opposer respectfully requests that this opposition proceeding be suspended pending the outcome of the civil action.
