### **NOTICE OF OPPOSITION**

FoodScience, LLC, a Vermont limited liability company with an address at 929 Harvest Lane, Williston, Vermont 05495 (hereinafter, "Opposer"), believes that it will be damaged by the registration of the mark which is set forth in Application Serial No. 90882669, filed by Hyland's Consumer Health, Inc., a Nevada corporation with an address at 13301 S. Main street, Los Angeles, California 90061 (hereinafter, "Applicant"), and hereby opposes registration of the same.

As grounds for opposition, Opposer alleges as follows:

- 1. Opposer uses the design mark in the U.S. in connection with a full line of dietary and nutritional supplements for pets and animals, as well as pet food and pet treats, with use dating from at least as early as August 19, 1991 (the "VetriScience Leaf Mark").
- 2. Opposer is the owner of U.S. Registration No. 6322068 for its VetriScience Leaf Mark for "Full line of dietary and nutritional supplements for pets and animals" in International Class 5 and "Pet food; edible pet treats; edible dog treats; edible pet treats designed to hide

medicine; edible chews for pets" in International Class 31. A true and correct copy of a printout from TSDR setting forth the details of the registration, which issued on April 13, 2021, is attached as **Exhibit A**.

3. On August 13, 2021, Applicant filed an application, Serial No. 90882669, to
