NOTICE OF OPPOSITION

Opposer Emerald X, LLC ("Opposer") is a Delaware limited liability company having its principal place of business at 100 Broadway, 14th Floor, New York, New York, 10005. Opposer believes that it will be harmed and damaged by the registration of the marks shown in Application Ser. Nos. 90/538,532 (the "'532 Application") and 90/538,524 (the "'524 Application", and together with the '532 Application, the "Subject Applications") applied for by applicant Outside Interactive, Inc. ("Applicant") and hereby opposes registration of the same (this "Opposition"). Opposer alleges as follows:

- 1. Opposer arranges and conducts engaging event experiences catering to niche communities of enthusiasts. Relevant here, Opposer has—since at least as early as June 25, 2021—arranged and conducted trade shows and exposition in the field of outdoor activities and sports known as OUTDOOR ADVENTURE EXPO.
- 2. On January 7, 2021, Opposer filed pending intent-to-use application 90/453, 211 (the "211 Application") for the mark OUTSIDE ADVENTURE EXPO 2*** (and Design) ("Opposer's Mark") identified for use in connection with [a]rranging and conducting trade shows and



expositions in the field [of] outdoor activities and sports in International Class 35. Opposer has used Opposer's Mark since at least as early as June 25, 2021. Exhibit A.

- 3. The '211 Application was published for opposition on July 12, 2022.
- 4. Upon information and belief, Applicant is a Delaware corporation having a principal place of business at 1600 Pearl Street, Suite 300, Boulder Colorado 80302.
- 5. On February 22, 2021—over a month after Opposer filed the '211 Application—Applicant filed the Applications for the mark OUTSIDE in standard characters and in a stylized format (the "Subject Marks") in connection with a variety of goods and services, including [a]rranging and conducting special events for commercial, promotional or advertising purposes; [o]rganization of events, exhibitions, fairs and shows for commercial, promotional and advertising purposes in International Class 35, [a]rranging and conducting of conventions in the field of sporting, fitness, athletics, health, nutrition, and the outdoors; [c]onducting entertainment exhibitions in the nature of sporting, fitness, athletics, health, nutrition, and the outdoors; [e]ducation services, namely, providing tutorial sessions in the field of sporting, fitness, athletics, and the outdoors; [e]ducation services, namely, providing classes and conferences in the field of sporting, fitness, athletics, and the outdoors in International Class 41 (the "Subject Expo Services").
- 6. Subsequently, on January 6, 2023, Applicant opposed registration of the '211 Application based upon, in part, the Subject Marks and an assertion that Opposer's Mark was likely to be confused with, among other things, ¹ the Subject Marks.

¹ Applicant references fifteen of its registrations in addition to the Subject Applications that incorporate the word OUTSIDE—none of which are identified for use in connection with the Subject Expo Services or services related to the Subject Expo Services.
