- 3. Petitioners incorporate the above paragraphs of Petitioners' grounds of cancellation against Registrant and makes such paragraphs a part hereof.
- 4. Registrant represented in its application that it used the Mark

  LAWYERFINDER.COM in connection with "providing a searchable database directory listing

  of lawyers via a global computer network", in International Class 35, and represented that its first

  use of the Mark in commerce with said goods and services was on September 20, 2010. See
