### REGISTRANT'S NOTICE OF RELIANCE

Registrant and Respondent, SnoWizard, Inc., ("SnoWizard") hereby submits this Notice of Reliance according to 37 C.F.R. §2.120 *et seq*. Respondent intends to rely upon the following evidence, which is hereby made of record in this matter.

- 1. The entire file wrapper of registration no. 4,157,907, which is automatically of record herein pursuant to 37 C.F.R. 2.122(b).
- 2. Copies of Petitioner's invoices produced by Petitioner attached hereto as Exhibit "A." The documents are relevant to show that Petitioner is a mere proxy of Southern Snow Manufacturing Co., Inc.("Southern Snow"), which was a plaintiff in numerous consolidated cases ("the consolidated cases") in the Eastern District of Louisiana, Case No. 06-9170 c/w 09-3394, 10-0791, and 11-1449 in which it relentlessly attacked registrations of SnoWizard, including WHITE CHOCOLATE & CHIPS®, by alleging the same finally adjudicated and rejected theories asserted herein.
- 3. A stamped copy of the judgement entered by the trial court in the consolidated cases attached hereto as Exhibit B. The judgment is relevant to clearly show that the mark WHITE CHOCOLATE & CHIPS® is not generic, merely descriptive, functional or was obtained by



fraud as alleged in the Petition for Cancellation.
