REQUEST FOR RECONSIDERATION AFTER FINAL ACTION DENIED

Issue date: July 3, 2024

Applicant's request for reconsideration is denied. *See* 37 C.F.R. §2.63(b)(3). The trademark examining attorney has carefully reviewed applicant's request and determined the request did not: (1) raise a new issue, (2) resolve all the outstanding issue(s), (3) provide any new or compelling evidence with regard to the outstanding issue(s), or (4) present analysis and arguments that were persuasive or shed new light on the outstanding issue(s). TMEP §§715.03(a)(ii)(B), 715.04(a).

Application History:

This Office action is in response to applicant's communication filed on August 23, 2023.

In a previous Office action(s) dated February 23, 2023, the trademark examining attorney refused registration of the applied-for mark based on the following: Trademark Act Section 2(d) for a likelihood of confusion with a registered mark. In addition, applicant was required to satisfy the following requirement(s): amend the identification of goods and/or services.

Based on applicant's previous response, the following requirement(s) have been satisfied: amended identification of goods provided. *See* TMEP §§713.02, 714.04.

Accordingly, the following requirement(s) and/or refusal(s) made final in the Office action dated December 5, 2023, are **maintained and continued**:

• Section 2(d) - Likelihood of Confusion Refusal

See TMEP §§715.03(a)(ii)(B), 715.04(a).

The examining attorney responds to applicant's arguments below:

Applicant's Arguments

Applicant argues that the nature of the goods and services are dissimilar. Specifically, applicant argues

that the evidence provided by the examining attorney does not show the services at issue being provided for the benefit others. The examining attorney has attached additional evidence from Cardinal Health, Medline, Mckesson, Stryker, Gotfried Medical, Luna Medical, Cascade Healthcare Solutions, Advantage Medical, and Byram Healthcare, which are entities that provide wearable garments for therapeutic purposes and also offer medical, health, and wellness information to others and healthcare providers.

Applicant argues that the nature of the goods and services provided are different. Specifically, applicant presents evidence from registrant's and applicant's website, to support the fact that the nature of the goods and services are different and that registrant does not provide any of applicant's goods. Determining likelihood of confusion is based on the description of the goods and/or services stated in the application and registration at issue, not on extrinsic evidence of actual use. *See In re Detroit Athletic Co.*, 903 F.3d 1297, 1307, 128 USPQ2d 1047, 1052 (Fed. Cir. 2018) (citing *In re i.am.symbolic, llc*, 866 F.3d 1315, 1325, 123 USPQ2d 1744, 1749 (Fed. Cir. 2017)). Furthermore, although registrant may not provide the applicant's goods, the evidence of record supports the fact that other entities provide the same goods and services at issue, under the same mark.

Applicant argues that the cited services are sold through completely different channels of trade. The examining attorney set forth in previous Office Actions that the services at issue for the services "Providing medical information services; providing health care information services by electronic means; providing medical, preventive, and wellness information to health care providers" in Class 44. The evidence previously attached and the evidence of record demonstrates that the goods and services not only travel in the same channels of trade, but often emanate from the same source.

Applicant argues that care would be exercised by purchasers of Applicant's Goods and the Cited Services. Specifically, applicant argues that the consumers are astute and careful in making decisions to purchase te goods and services and the goods and services are not purchased on impulse. Even if consumers of the compared goods and/or services could be considered sophisticated and discriminating, it is settled that "even sophisticated purchasers are not immune from source confusion, especially in cases such as the present one involving identical marks and related goods [and/or services]." *In re i.am.symbolic, llc*, 116 USPQ2d 1406, 1413 (TTAB 2015) (citing *In re Research & Trading Corp.*, 793 F.2d 1276, 1279, 230 USPQ 49, 50 (Fed. Cir. 1986)), *aff'd*, 866 F.3d 1315, 123 USPQ2d 1744 (Fed. Cir. 2017); *see also In re Shell Oil Co.*, 992 F.2d 1204, 1208, 26 USPQ2d 1687, 1690 (Fed. Cir. 1993). The identity of the marks and the relatedness of the goods and/or services "outweigh any presumed sophisticated purchasing decision." *In re i.am.symbolic, llc*, 116 USPQ2d at 1413 (citing *HRL Assocs., Inc. v. Weiss Assocs., Inc.*, 12 USPQ2d 1819, 1823 (TTAB 1989), *aff'd*, 902 F.2d 1546, 14 USPQ2d 1840 (Fed. Cir. 1990)); *see also Stone Lion Capital Partners, LP v. Lion Capital LLP*, 746 F.3d 1317, 1325, 110 USPQ2d 1157, 1163-64 (Fed. Cir. 2014).

If applicant has already filed an appeal with the Trademark Trial and Appeal Board, the Board will be notified to resume the appeal. *See* TMEP §715.04(a).

If applicant has not filed an appeal and time remains in the response period for the final Office action, applicant has the remainder of that time to (1) file another request for reconsideration that complies with and/or overcomes any outstanding final requirement(s) and/or refusal(s), and/or (2) file a notice of appeal to the Board. TMEP §715.03(a)(ii)(B).

Private companies may call you and pretend to be the USPTO or may send you communications that resemble official USPTO documents to trick you. We will never request your credit card number or social security number over the phone. Verify the correspondence originated from us by using your serial number in our database, <u>TSDR</u>, to confirm that it appears under the "Documents" tab, or contact the <u>Trademark Assistance Center</u>.

• Hiring a U.S.-licensed attorney. If you do not have an attorney and are not required to have one under the trademark rules, we encourage you to hire a U.S.-licensed attorney specializing in trademark law to help guide you through the registration process. The USPTO examining attorney is not your attorney and cannot give you legal advice, but rather works for and represents the USPTO in trademark matters.
