# MOTION FOR EXTENSION OF TIME TO FILE EX PARTE APPEAL BRIEF

2. During the last seven (7) weeks, the undersigned's workload increased due to several matters, including a patent infringement trial that had been slated to being during the two-

During that time, the undersigned had also engaged with counsel for the owner of the trademark registration cited against the Owner/Appellant to complete negotiation of a co-existence agreement between the parties. Because of the Christmas, Hanukkah and New Year's holidays, it has been difficult to get the agreement signed by the persons in authority to sign on behalf of the entities involved. Appellant believes that the co-existence agreement will likely render the refusal moot and respectfully submits that a request for reconsideration in view of the co-existence agreement would benefit Appellant as well as the U.S. Patent & Trademark Office.
