## MICROSOFT CORPORATION'S MOTION TO STAY PROCEEDINGS PENDING RESOLUTION OF MICROSOFT'S MOTION TO TRANSFER

Defendant Microsoft Corporation ("Microsoft") respectfully moves this Court to stay all other proceedings in this matter—including Local Patent Rule disclosures and fact discovery—pending resolution of Microsoft's Motion to Transfer Venue to the Western District of Washington, or in the Alternative, to the Northern District of California. The Federal Circuit has indicated that a promptly filed motion to transfer under §1404(a), along with a motion to stay proceedings pending disposition of the transfer motion should be acted on promptly and before proceeding the merits of the action. *Fusion-IO, Inc.*, No. 12-139, 2012 WL 6634939 (Fed. Cir. Dec. 21, 2012); *In re EMC Corp*, Misc. No. 142, 2013 WL 324154 (Fed. Cir. Jan. 29, 2013).
