**JOINT MOTION TO STAY PROCEEDINGS
PENDING FINALIZATION OF SETTLEMENT**

Plaintiffs Uniloc USA, Inc., and Uniloc Luxembourg, S.A. (together “Uniloc”), and Defendant, Big Fish Games, Inc. (“Big Fish Games”), jointly move to stay this action pending finalization of settlement.
