**JOINT MOTION TO CONTINUE THE STAY BETWEEN PLAINTIFFS AND
DEFENDANT KYOCERA INTERNATIONAL, INC. PENDING FINALIZATION OF
SETTLEMENT**

Plaintiffs Uniloc USA, Inc., and Uniloc Luxembourg, S.A. (together “Uniloc”), and Defendant Kyocera International, Inc. (“Kyocera”), hereby jointly file this Joint Motion to Continue the Stay with respect to the stay currently in place between Uniloc and Kyocera pending finalization of settlement.

The parties have reached an agreement to settle the case, and are in the process of finalizing payment under the written settlement agreement. The parties wish to conclude the settlement without burdening the Court with any additional filings and without incurring unnecessary expense. The parties believe that this can be accomplished within fourteen (14) days.

Accordingly, Uniloc and Kyocera respectfully request that the Court grant a 14-day stay of proceedings between them, including all deadlines, until June 29, 2017.

The parties submit that good cause exists for granting this agreed motion, as set forth above. This motion is not filed for purposes of delay, but so that justice may be served.

A proposed order granting this Joint Motion is attached.

Wherefore, Plaintiffs Uniloc and Defendant Kyocera, jointly, respectfully request that the Court enter the proposed order submitted with this Motion as set forth above, and grant the parties such other and further relief to which they are entitled.
