AND HUAWEI DEVICE (DONGGUAN) CO., LTD.’S AND LG ELECTRONICS INC.’S MOTION TO STAY (DKT. 102) PENDING RESOLUTION OF HUAWEI’S MOTION TO TRANSFER (DKT. 36) AND LGEKR’S MOTION TO DISMISS OR TRANSFER (DKT. 46)

Plaintiff Agis Software Development LLC (“Plaintiff”) and Defendants Huawei Device USA Inc., Huawei Device Co., Ltd., Huawei Device (Dongguan) Co., Ltd., (collectively, “Huawei”) and LG Electronics Inc.
