### Vincent,

I'm sorry we were not able to connect this afternoon. I'm not quite sure I understand your objection. As you know, the only primary reference in Mr. Siegel's expert report re: invalidity is the FBCB2 system. The relevant factual information sought by AGIS's subpoena topics—i.e., the operation, design, and development of the FBCB2 system; the dates and circumstances of the system's development; the public availability of the system; the documents that describe the operation of the system; etc.—is in the expert report. This is precisely why the procedure the parties agreed to—a single deposition after expert reports—made sense in the first place.

Under the circumstances, seven hours should be sufficient. Is there some specific reason you think it is not, or some specific issue for which you believe extra time is required? Please let me know; I'm happy to discuss. But also note that if it is your position that you need more than seven hours, which will therefore likely require a second day of testimony, we'll need to take the November 14 date off calendar and reschedule to early December while we negotiate a resolution.

So that we can make any necessary adjustment to travel plans, please let me know no later than Sunday morning if you believe you need more than seven hours, and if so, how much extra time and the specific issue(s) for which you believe extra time is needed. I am available to discuss this weekend if it would be helpful.
