JOINT MOTION TO FURTHER EXTEND STAY OF ALL DEADLINES

Plaintiff AGIS Software Development LLC (“AGIS”) and Defendants Huawei Device USA Inc., Huawei Device Co., Ltd., and Huawei Device (Dongguan) Co., Ltd. (collectively, “Huawei” or “Defendants”) hereby respectfully and jointly request that this Court further extend the stay of all deadlines between AGIS and Huawei for an additional twenty eight (28) days to March 14, 2019 in order to allow the parties to finalize documentation of settlement and to file dismissal documents with the Court. Good cause exists for the extension due to foreign-located Huawei representatives requiring additional time to execute the settlement documents. More specifically, the settlement documents have been executed by AGIS and are now being sent to China for execution by Huawei.
