JOINT MOTION TO AMEND DOCKET CONTROL ORDER

Plaintiff Agis Software Development, LLC and Defendants LG Electronics Inc. and HTC Corporation (collectively “The Parties”) hereby file this Joint Motion to Amend Docket Control Order. The parties have recently met and conferred regarding the deadline to file Motions *in Limine*. The parties note that currently, the deadline for both the Motions *in Limine* as well as the Responses to Motions *in Limine* is February 18, 2019. The parties agree to amend the Docket Control Order to move the deadline to file Motions *in Limine* to February 11, 2019, one week earlier, to allow time for the parties to respond to those Motions. February 18, 2019	February 11, 2019	File Motions <i>in Limine</i> The parties shall limit their motions <i>in limine</i> to issues that if improperly introduced at trial would be so prejudicial that the Court could not alleviate the prejudice by giving appropriate instructions to the jury.
February 18, 2019	Unchanged	Serve Objections to Rebuttal Pretrial Disclosures
February 13, 2019	Unchanged	Serve Objections to Pretrial Disclosures; and Serve Rebuttal Pretrial Disclosures
February 8, 2019	Unchanged	Serve Pretrial Disclosures (Witness List, Deposition Designations, and Exhibit List) by the Party with the Burden of Proof
February 8, 2019	Unchanged	*File Notice of Request for Daily Transcript or Real Time Reporting. If a daily transcript or real time reporting of court proceedings is requested for trial, the party or parties making said request shall file a notice with the Court and e-mail the Court Reporter, Shelly Holmes, at shelly_holmes@txed.uscourts.gov.

February 8, 2019	Unchanged	<p>Deadline to Complete Mediation</p> <p>The parties are responsible for ensuring that a mediation report filed no later than 5 days after the conclusion of mediation.</p>
