Enrique,

Our code has been available for nearly half a year, and AGIS's failure to request inspection is its own fault.

I informed Ms. Messing that our source code was available for inspection via a May 16 letter. My letter asked for one-week notice to allow our staff time to set up an office. Ms. Messing and I had a meet and confer on May 17 and, on that call, I told her that our source code was available and again asked for one week notice. The ball was very clearly in AGIS's court since then to request inspection.

On July 31, Mr. Rubino provided a generic source-code related complaint to HTC via letter. From his letter, it was clear that he did not check with Ms. Messing or read my past correspondence prior to sending his letter. On August 16, I responded via letter telling Mr. Rubino that our source code was available, and has been since May 16. In my letter, I detailed the previous correspondence and meet and confer between Ms. Messing and I.

From your e-mail, it appears that you did not check with Ms. Messing or Mr. Rubino, or read my prior letters. The Brown Rudnick team is simply not communicating with each-other and not reading past letters (or perhaps your team is confusing HTC with another Android defendant?).

Our source code computer shall be ready on October 3. To make clear, I have repeatedly told Brown Rudnick attorneys that HTC does not have the source code for the accused applications. HTC has repeated that in its court filings and in our discovery responses. The source code will have the source code in HTC's possession, custody, or control.
