7 Q. So let's start with the first line, LifeRing server
8 license. What does that refer to?

9 A. Well, that refers to our server. Now, we provide our
10 software, you can buy the software for the phone, not buy it
11 for the server, you purchase the license for the software. And
12 the first line refers to the server software, and people buy
13 the server software, because in the military they don't want us
14 to know where they are.

15 First responders fall under a thing called HIPAA,
16 which is a rule to protect the privacy of individuals that have
17 a medical problem or something. First responders, police and
18 fire, therefore, buy the server, as well as some companies
19 have, and it's \$30,000. And for that you own the server
20 software, and we guarantee it for the first year, and provide
21 you updates for the first year as part of that purchase.

22 Q. Okay. And the third line there, LifeRing PDA license, to
23 what does that refer?

24 A. That's the cost for the software if you're buying it,
25 again, you own it, for your phone.
