## JOINT MOTION FOR ENTRY OF SECOND AMENDED DOCKET CONTROL ORDER

Plaintiff AGIS Software Development LLC ("AGIS") and Defendants HTC Corporation ("HTC") and LG Electronics, Inc. ("LG") (collectively, "Parties"), hereby submit this Joint Motion for Entry of a Second Amended Docket Control Order and show the Court as follows:

Good cause exists for requesting the extensions of time reflected in the proposed Second Amended Docket Control Order.
