UNOPPOSED MOTION FOR EXTENSION OF TIME  
TO RESPOND TO PLAINTIFF'S MOTION FOR SUMMARY JUDGMENT  
REGARDING OWNERSHIP AND STANDING

Defendant Uber Technologies, Inc. ("Defendant") respectfully moves the Court to extend the time to respond to Plaintiff's Motion for Summary Judgment of Ownership and No Evidence of Lack of Standing to Assert Patent Infringement (Dkt. 277).
