On April 23, 2021 Defendant Uber Technologies, Inc. (“Uber”) filed a Motion to Dismiss (Dkt. No. 24) and a Motion to Stay Pending Resolution of Standing Issues (Dkt. No. 25). AGIS Software Development LLC (“Plaintiff”) filed its oppositions to Uber’s Motions on May 7, 2021 (Dkt. No. 42; Dkt. No. 43); Uber filed its replies in support of its Motions to on May 17, 2021 (Dkt. No. 51; Dkt. No. 52); and Plaintiff filed its sur-replies in opposition to Uber’s Motions on May 31, 2021 (Dkt.
