JOINT MOTION FOR EXTENSION OF TIME AS TO INFRINGEMENT AND INVALIDITY CONTENTIONS

Plaintiff Jawbone Innovations, LLC ("Plaintiff") and Defendants Samsung Electronics Co., Ltd. ("SEC") and Samsung Electronics America, Inc. ("SEA") (together, SEC and SEA are "Samsung"; collectively with Plaintiff, the "Parties") jointly move the Court for a brief 21-day extension of the deadlines to comply with P.R. 3-1 and 3-2 (infringement contentions) and P.R. 3-3 and P.R. 3-4 (invalidity contentions), as set for the below:

In support of their joint motion, the Parties state as follows:

1. On October 26, 2021, Plaintiff filed an amended complaint, alleging infringement of the two originally asserted patents (U.S. Patent Nos. 8,019,091 and 8,280,072) plus five



additional patents (U.S. Patent Nos. 7,246,058, 8,467,543, 8,503,691, 10,779,080, and 11,122,357), for a total of seven patents now asserted against Samsung. (Dkt. 21.)

- 2. On December 14, 2021, the Court set a scheduling conference for January 13, 2022. (Dkt. 28.) No trial date has been set.
- 3. Given the number of asserted patents, and in light of the holiday season, the Parties have agreed to a brief 21-day extension in the deadline for infringement and invalidity contentions.

WHEREFORE, the Parties respectfully request that the Court enter an order extending the above deadlines.
