**ORDER GRANTING JOINT MOTION FOR EXTENSION OF TIME FOR
PLAINTIFFS ADVANCED MICRO DEVICES, INC. AND ATI TECHNOLOGIES ULC
TO COMPLY WITH P. R. 3-1 & 3-2 (INFRINGEMENT CONTENTIONS) AND FOR
DEFENDANT REALTEK SEMICONDUCTOR CORP. TO COMPLY WITH P. R. 3-3 &
3-4 (INVALIDITY CONTENTIONS) AND STANDING ORDER REGARDING
SUBJECT-MATTER ELIGIBILITY CONTENTIONS**

Before the Court is Plaintiffs Advanced Micro Devices, Inc. and ATI Technologies ULC's (collectively, "AMD") Joint Motion for Extension of Time to Comply with P. R. 3-1 & 3-2 (Infringement Contentions) and Defendant Realtek Semiconductor Corp.'s ("Realtek") Joint

Motion for Extension of Time to Comply with P. R. 3-3 & 3-4 (Invalidity Contentions) and to comply with the Standing Order Regarding Subject-Matter Eligibility Contentions.

After consideration, the Court **GRANTS** the Joint Motion for Extension of Time. It is therefore **ORDERED** that the Parties' new deadlines are as follow:
