JOINT MOTION FOR STAY OF ALL DEADLINES AND NOTICE OF SETTLEMENT

Plaintiff AGIS Software Development LLC (“Plaintiff” or “AGIS”) and Defendants Samsung Electronics Co., Ltd. and Samsung Electronics America, Inc. (collectively, “Defendants” or “Samsung) (Plaintiff and Defendants, collectively, the “Parties”) have met and conferred and jointly submit this request for a stay of all case deadlines.

On January 15, 2024, the Court granted the Parties request for a partial stay of all deadlines involving Google Products in connection with an agreement in principle between Plaintiff and third-party Google LLC. Dkt. 175, 176.

The Parties hereby notify the Court that AGIS and Samsung have reached an agreement in principle to settle all remaining claims and counterclaims for relief in this litigation.

Accordingly, the Parties jointly move the Court to enter a stay of all deadlines in the case, including as set forth in the Court’s Second Amended Docket Control Order (Dkt. 121), for thirty (30) days to allow the settlement to be finalized and dismissal papers to be submitted. This stay is not sought for the purpose of delay, but so that justice may be served.
