## ORDER GRANTING JOINT MOTION FOR EXTENSION OF TIME TO COMPLY WITH P. R. 3-1 & 3-2 (INFRINGEMENT CONTENTIONS) AND TO COMPLY WITH P. R. 3-3 & 3-4 (INVALIDITY CONTENTIONS) AND STANDING ORDER REGARDING SUBJECT-MATTER ELIGIBILITY CONTENTIONS

Before the Court is Plaintiff AGIS Software Development LLC's ("Plaintiff" or "AGIS") Joint Motion for Extension of Time to Comply with P. R. 3-1 & 3-2 (Infringement Contentions) and Defendants HMD Global OY ("HMD Global OY") and HMD America, Inc. ("HMD America") (collectively, "HMD"); ASUSTek Computer Inc. ("ASUSTek Computer") and ASUS Computer International ("ASUS Computer") (collectively, "ASUS"); Panasonic Holdings Corporation, formerly known as Panasonic Corporation ("Panasonic Corp.") and Panasonic Corporation of North America ("Panasonic Corp. of NA") (collectively, "Panasonic"); and Sony Corporation, formerly known as Sony Mobile Communications, Inc. ("Sony") (all Defendants, collectively, "Defendants") Joint Motion for Extension of Time to Comply with P. R. 3-3 & 3-4 (Invalidity Contentions) and to comply with the Standing Order Regarding Subject-Matter Eligibility Contentions.

After consideration, the Court GRANTS the Joint Motion for Extension of Time. It is therefore ORDERED that AGIS will have up to and including **December 11, 2023** to comply with P. R. 3-1 & 3-2 (Infringement Contentions). It is further ORDERED that Defendants will have up

to and including **February 5, 2024** to comply with P. R. 3-3 & 3-4 (Invalidity Contentions) and to comply with the Standing Order Regarding Subject-Matter Eligibility Contentions.
