Counsel,

In light of the court's comments following the hearing yesterday, we propose that the parties revise—and substantially reduce—their respective exhibit lists. The court made clear that submission of exhibit lists with over 500 exhibits will not be tolerated.

Therefore, we propose the parties exchange revised exhibit lists (to include rebuttal exhibits, too) on Wednesday, May 16. The parties should endeavor to limit their respective lists to no more than 200 exhibits, including rebuttal exhibits. We also propose the parties provide their objections to the exhibit lists on May 22. This would replace the current schedule, but for exhibits only. The schedule for the remaining pretrial disclosures would remain unchanged.

In light of today's deadline, please let us know as soon as possible if you agree. If you do not agree, we will ultimately raise the issue of ZTE's 500+ exhibit list with the court, but we believe this proposal is workable and we are hopeful that we need not reach out to the court to resolve this particular issue.
