JOINT MOTION TO AMEND DOCKET CONTROL ORDER

Plaintiff Cellular Communications Equipment LLC (“CCE”) and Defendants (collectively, the “Parties”) have conferred regarding remaining case deadlines associated with claim construction and agree to the following proposed modifications to the Court’s Docket Control Order, as amended November 9, 2015 Order (Dkt. 146).

Accordingly, the Parties jointly file this motion requesting the Court enter the proposed order attached hereto, which extends deadlines as specified below:

*Comply with P.R. 4-5(c) (Reply Claim Construction Brief) (including any expert declaration regarding indefiniteness)	November 16, 2015	November 18, 2015

The proposed amendments extend CCE’s P.R. 4-5(c) deadline by two days, and extend both Defendants’ deadline to file a Sur-Reply Claim Construction Brief and the Parties’ deadline to comply with P.R. 4-5(d) by one week. The proposed deadlines comply with P.R. 4-5(d) and ensure that all claim construction deadlines (including submission of the P.R. 4-5(d) Joint Claim Construction Chart) will be met 17 days before the claim construction hearing. The Parties seek these extensions of time not for delay but for good cause and to provide additional time to complete claim construction briefing. Accordingly, the Parties respectfully ask the Court to enter the proposed order attached hereto.
