**CHILD SUPPORT REVIEW ORDER**

On the 6<sup>th</sup> day of November 2013, a negotiation conference was held pursuant to Texas Family Code Chapter 233. The Office of the Attorney General appeared by a duly authorized representative. FELICITAS SERRANO, mother of the child, hereinafter referred to as Obligee, participated by teleconference. JAMES ALEXANDER SERRANO a/k/a JAMES ALEXANDE SERRANO, father of the child, hereinafter referred to as Obligor, appeared in person and agreed to the entry of these orders as evidenced by his signature.

The following agreements and/or findings are the result of the negotiation conference.

It is FOUND that the Court has jurisdiction of the parties and the subject matter of this suit, and that the following orders are in the best interest of the child.

## MODIFICATION OF SUPPORT ORDER

It is FOUND that since rendition of the support and health care coverage order entitled *FINAL DECREE OF DIVORCE* signed on **October 30th, 2009** there has been a material and substantial change in the circumstances of the child or parties, or it has been three years since the order was rendered or last modified and the monthly amount of the child support award under the order differs by either 20 percent or \$100 from the amount that would be awarded in accordance with the child support guidelines, or the existing order for child support does not include health coverage for the child as required under TFC §154.182, which warrants the following modification of the existing support order.

*JAMES ALEXANDER SERRANO* is paid ahead in the amount of \$365.39 as of 11/05/2013. *als.*

### FINDINGS REGARDING MEDICAL SUPPORT AND CHILD SUPPORT OBLIGATIONS

It is FOUND:

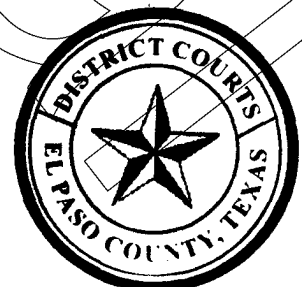
*JAMES ALEXANDER SERRANO*'s gross monthly resources are **\$8,283.88**.

Reasonable cost, based upon 9% of *JAMES ALEXANDER SERRANO*'s gross monthly resources is **\$746.00**.

*JAMES ALEXANDER SERRANO* is obligated to provide support for the following:

- (A) The number of children before the court is *one (1)*.
- (B) The number of minor children not before the court residing in the same household with *JAMES ALEXANDER SERRANO* is *zero (0)*.
- (C) The number of children not before the court for whom *JAMES ALEXANDER SERRANO* is obligated by a court order to provide **medical support**, and who are not counted under Paragraph (A) or (B) is *zero (0)*.
- (D) The number of children not before the court for whom *JAMES ALEXANDER SERRANO* is obligated by a court order to provide **child support**, including those counted in (C) above, and who are not counted under Paragraph (A) or (B) is *zero (0)*.

*FELICITAS SERRANO* provides health insurance coverage for *zero (0)* other minor children.



**MEDICAL SUPPORT**

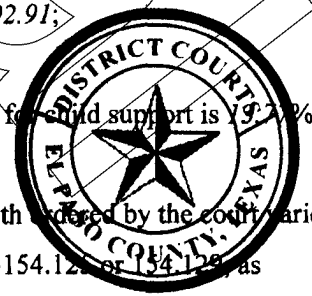

It is further FOUND that the following orders regarding health insurance are in the best interest of the child.

**CHILD SUPPORT GUIDELINE FINDINGS**

It is FOUND that, pursuant to Texas Family Code §154.130:

- (1) the net resources of *JAMES ALEXANDER SERRANO* per month are \$ 5,992.91;
- (2) the net resources of *FELICITAS SERRANO* per month are \$ 1,118.20;
- (3) the percentage applied to *JAMES ALEXANDER SERRANO*'s net resources for child support is 15.7%;  
and
- (4) if applicable, the specific reasons that the amount of child support per month ordered by the court varies from the amount computed by applying the percentage guidelines under §§154.121 or 154.122, as applicable.

**HEALTH INSURANCE TO BE PROVIDED BY OBLIGOR, JAMES ALEXANDER SERRANO**

As additional child support, *JAMES ALEXANDER SERRANO* is ORDERED to obtain, within 15 days after entry of this order, health insurance for each child who is the subject of this suit that covers basic health care services, including usual physician services, office visits, hospitalization, laboratory, x-ray, and emergency services through *JAMES ALEXANDER SERRANO*'s employment or membership in a union, trade association, or other organization.

*JAMES ALEXANDER SERRANO* is ORDERED to maintain such health insurance in full force and effect for any child, subject of this suit, until the first of the following events occurs for the child:

1. the child reaches the age of eighteen years or graduates from high school, whichever occurs later, subject to the provisions for support beyond the age of eighteen years set out below;
2. the child marries;
3. the child dies;
4. the child enlists in the armed forces of the United States and begins active service as defined by section 101 of title 10 of the United States Code; or
5. the child's disabilities are otherwise removed for general purposes.

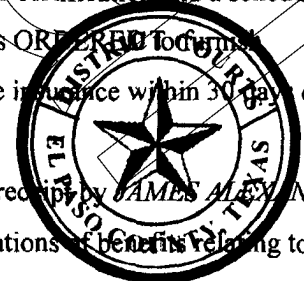
If the child is eighteen years of age and has not graduated from high school, IT IS ORDERED that this obligation shall not terminate but shall continue for as long as the child is enrolled

1. under chapter 25 of the Texas Education Code in an accredited secondary school in a program leading toward a high school diploma or under section 130.008 of the Education Code in courses for joint high school and junior college credit and is complying with the minimum attendance requirements of subchapter C of chapter 25 of the Education code; or
2. on a full-time basis in a private secondary school in a program leading toward a high school diploma and is complying with the minimum attendance requirements imposed by that school.

*JAMES ALEXANDER SERRANO* is ORDERED to convert any group insurance to individual coverage for each child within 15 days of termination of his employment or other disqualification of him from the group insurance. *JAMES ALEXANDER SERRANO* is ORDERED to exercise any conversion options in such a manner that the resulting insurance equals or exceeds that immediately before the conversion.

*JAMES ALEXANDER SERRANO* is ORDERED to furnish *FELICITAS SERRANO* and the Office of the Attorney General Child Support Division a true and correct copy of the health insurance policy or certification and a schedule of benefits within 30 days of the signing of this order. *JAMES ALEXANDER SERRANO* is ORDERED to furnish *FELICITAS SERRANO* the insurance cards and any other forms necessary for use of the insurance within 30 days of the signing of this order.

*JAMES ALEXANDER SERRANO* is ORDERED to provide, within three days of receipt by *JAMES ALEXANDER SERRANO*, to *FELICITAS SERRANO* any insurance checks, other payments, or explanations of benefits relating to any medical expenses for the child that *FELICITAS SERRANO* paid or incurred.
