Now if I shall well and truly make said appearance before the said Court, and there remain from day to day and term to term of said Court, until discharged by due course of law, then and there to answer said accusation against me, and further shall well and truly make my personal appearance in any and all subsequent proceedings that may be had relative to said charge in the course of the criminal action based on said charge, this obligation shall become void; otherwise to remain in full force and effect.

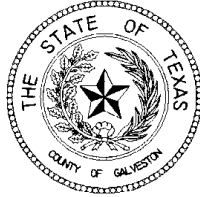

**RELEASE OF INFORMATION**

I, the undersigned, hereby request that the Pretrial Release Agency staff investigate the alleged facts surrounding my arrest, charges, convictions or any other type of unlawful conduct, which may include the examination of both juvenile and adult records of the undersigned, in addition to conducting a general background investigation.

In consideration of the Pretrial Release Agency's investigation of the possibility of my acceptance into, or, if accepted, my participation in the program, I the undersigned hereby release, remise and discharge the Galveston County Pretrial Release Agency, its board and employees, Galveston County and any and all law enforcement agencies, persons, firms, and/or corporations from any claims or liability whatsoever for the release of any information deemed necessary by the Pretrial Release Agency in the normal course of its business.

I understand and hereby acknowledge that all fees paid to Pretrial Release are non-refundable.

**RULES AND REGULATIONS FOR ALL CHARGES**

1. Report by phone each month as instructed by the Pretrial Agency.
2. Notify the Pretrial Release Agency immediately if I change my address, telephone number or employment.
3. I understand a court notice is sent to the last address on file and, therefore, it is important to report any changes in address. I further understand that, although I will receive a notice to appear, the ultimate responsibility to appear before the court is upon me.
4. I understand that I may not leave the state or county for more than one week without the written permission of the Pretrial Release Agency.
5. I understand that my bond may be surrendered and a warrant issued for my arrest if I am involved in any unlawful conduct while awaiting trial.

**FELONY CHARGES**

In addition to the rules above, the follow may apply:

6. I agree to secure the services of an attorney, within 15 days after indictment, or my release from jail.
7. If I have been unable to hire an attorney, I understand and agree that I will appear before the judge of the Criminal District Court as scheduled and explain why.
