CONDITION OF BAIL: NO CONTACT

It is hereby ORDERED that, as a condition of release on a surety, cash, or personal bond, in addition to any other conditions of bail presently in effect, that you, Defendant, shall comply with the following conditions of bail:

✓ NO CONTACT OF ANY KIND: You shall not communicate directly, or indirectly, in any manner with Tyler Owens, hereafter referred to as Complainant, except through your attorney, the Complainant's attorney or a person appointed by the court.

You shall not communicate directly, or indirectly, in any manner with any member of the family or the household of the Complainant, unless specifically permitted to do so by court order of a family district court.

NO HARRASSING CONTACT: You shall not directly, or indirectly, in any manner, communicate in a threatening or harassing manner, or commit any act of violence or intimidation directed at Tyler Owens, Complainant, or a member of Complainant's family or household.

You shall not go by, to, or near the residence of the Complainant, specifically, within 200 feet of: 18477 Sunrise Oaks Court Montgomery TX 77316

You shall not go by, to, or near the school or place of business of the Complainant, specifically, within 200 feet of:

You shall not go by, to, or near the residence, place of employment, school or childcare facility of the Complainant's family or household member, namely, \_\_\_\_\_, and, specifically, within 200 feet of:

You shall not communicate directly, or indirectly, or in any manner described above with: \_\_\_\_\_, witness (es) in this case.

IT IS FURTHER ORDERED that this Order is effective immediately and shall continue in effect until this case is resolved by conviction, acquittal or dismissal.

Violation of this Order may result in revocation and/ or increase of the defendant's bond, and subsequent arrest. Violation of this Order may result in the filing of additional charges including but not limited to Contempt of Court, punishable by a fine not to exceed \$500 and/or confinement in jail for a period not to exceed 180 days.

NO PERSON, INCLUDING ONE WHO IS PROTECTED BY THIS ORDER, MAY GIVE PERMISSION TO DEFENDANT, OR OTHER PERSON, TO IGNORE OR VIOLATE ANY PROVISION OF THIS ORDER. EVERY PROVISION OF THIS ORDER IS IN FULL FORCE AND EFFECT FOR THE DURATION OF THIS CASE, UNLESS SPECIFICALLY MODIFIED BY THE COURT IN WRITING.
