DEFENDANT'S ACKNOWLEDGMENT OF RECEIPT OF ORDER AND PÄYMENT PLAN

I, Defendant, understand that a judgment has been entered against me in favor of the State of Texas for a fine and costs totaling \$764.00 plus an additional \$2.00 each time I make a payment: that in the discretion of the court, I can satisfy this judgment by paying the fine and costs in one or more installment payments; by performing community service, or, if I am able to pay and willfully refuse to pay, by being placed in the Harris County Jail until the fine and court costs are satisfied.
