

Cause may hereafter be pending at any time when, and place where, my presence may be required under the Code of Criminal Procedure of the State of Texas or by any such court or magistrate and for any and all subsequent court proceedings had, relative to the charge, to answer the accusation against me.

CONDITIONED, that I as principal, give my personal bond as set out above, for my personal appearance. "I swear that I will appear before the 8 court or magistrate at the Family Law Center located at 1115 Congress Street, Houston, Harris County, Texas, on the 9th day of April, 2018, at the hour of 11 a.m. or p.m. or upon notice by the court, or pay to the court the principal sum of 2,001 DOLLARS (\$2,001) plus all necessary and reasonable expenses incurred in any arrest for failure to appear."

Now, if I as principal shall make my personal appearance as provided for herein before said court or magistrate, and there remain from day to day and term to term of said court, then and there to answer the accusation against me, and shall personally appear as provided for herein before any court or magistrate in which this said cause may hereafter be legally pending as well as before any other court to which said cause may be transferred, at any time when, and place where, my presence may be required under the Code of Criminal Procedure of the State of Texas or by any such courts or magistrate, until discharged by due course of law; then the above bond will be null and void. I understand that I can contact the District Clerk's automated public assistance line (832-927-5800) in order to find all my future court dates.

"I, Ed Gonzalez, Sheriff of Harris County, have been ordered to release all defendants in my custody who have either gone before a magistrate with an affidavit of inability to pay, and the hearing officer has failed to grant them a personal recognizance bond or have not appeared at a probable cause hearing within 24 hours. See *Odonnell et al., v. Harris County, et al.*, Civ. Act. H-16-1414, Order of Prelim. Inj., (S.D. Tex. April 28, 2017).

In this case, I make the following findings:

1. This defendant is in my custody being held on a misdemeanor charge.
2. This defendant is not charged with a Violation of Certain Court Orders or Conditions of Bond in a Family Violence, Sexual Assault or Abuse, Stalking or Trafficking Case under Texas Penal Code Sec. 25.07.
3. A Hearing Officer or a Harris County District Attorney has determined that the defendant's bond amount is: 2,001.
4. (A.) This defendant has not had a bail-setting hearing before a Hearing Officer within 24 hours of arrest; or
(B.) This defendant has executed an affidavit showing an inability to pay secured money bail and the Hearing Officer did not order release either: (1) on an unsecured personal bond with nonfinancial conditions of release; or (2) on a secured money bond for which the defendant could pay a commercial surety's premium.

It is THEREFORE the ORDER of the Sheriff of Harris County that the defendant is hereby released promptly without the requirement of a surety. All nonfinancial conditions of release ordered by the Hearing Officers, including protective orders, drug testing, alcohol intake ignition locks, or GPS monitoring, will remain in effect."
