**PARTIES' JOINT MOTION FOR EXTENSION OF TIME TO  
FILE JOINT CLAIM CONSTRUCTION STATEMENT**

Plaintiff Bandspeed, LLC (“Plaintiff”) and Defendant Realtek Semiconductor Corporation (“Defendant”) (collectively, “the Parties”) hereby jointly move to extend the deadline to file their Joint Claim Construction Statement by one (1) week. In support of the motion, the Parties state as follows:
