**NOTICE OF AGREED EXTENSION OF DEADLINES FOR
CLAIM CONSTRUCTION BRIEFING**

Defendants in the above captioned cases notify the Court that, to provide the Parties with additional time to meet and confer to try to further narrow the claim construction disputes, the
