



The Court will conduct a further status conference with the parties to address discovery and other issues approximately a month after the September 27 hearing and hereby ORDERS the following relief:

<u>Issue</u>	<u>Disposition</u>
Whether the Court should strike Demaray's infringement claims for claims 2, 4, 6-7, 10-12, 14, 17, 20 and 21 of the '657 patent and any forthcoming supplementations which Defendants assert Demaray did not chart on February 5, 2021 for which Demaray has indicated it intends to include in its infringement contentions?	The Court denies Defendants' request. Plaintiff may include contentions regarding claims 2, 4, 6-7, 10-12, 14, 17, 20 and 21 of the '657 patent in its infringement contentions. The Court will move the close of fact discovery and close of expert discovery by 60 days. The trial date has been reset to June 13, 2022. The parties will meet and confer and submit a proposed schedule. The parties will meet and confer on whether further claim construction is necessary and, if so, propose a schedule for briefing. The Court may set another <i>Markman</i> hearing if necessary.
Whether the Court should strike or compel Plaintiff to provide more detail on its doctrine of equivalents theories?	If Plaintiff has not articulated doctrine of equivalents theories prior to the next status conference, Defendants may raise the issue with the Court at that time.
