**ORDER REGARDING JOINT STIPULATION TO AMEND SCHEDULE**

After considering the Parties' Joint Stipulation to Amend Schedule, the Court amends the case deadlines as follows:


Date	Deadline
11/04/2022	Deadline for the first of two meet and confers to discuss significantly narrowing the number of claims asserted and prior art references at issue. Unless the parties agree to the narrowing, they are ordered to contact the Court's Law Clerk to arrange a teleconference with the Court to resolve the disputed issues.
2/09/2023	Close of Fact Discovery
3/16/2023	Opening Expert Reports
4/27/2023	Rebuttal Expert Reports
5/31/2023	Close of Expert Discovery

Date	Deadline
6/05/2023	Deadline for the second of two meet and confer to discuss narrowing the number of claims asserted and prior art references at issue to triable limits. To the extent it helps the parties determine these limits, the parties are encouraged to contact the Court's Law Clerk for an estimate of the amount of trial time anticipated per side. The parties shall file a Joint Report within 5 business days regarding the results of the meet and confer.
6/15/2023	Dispositive motion deadline and <i>Daubert</i> motion deadline
6/29/2023	Serve Pretrial Disclosures (jury instructions, exhibits lists, witness lists, designations)
7/17/2023	Parties to jointly email the Court's law clerk to confirm their pretrial conference and trial dates.
7/20/2023	Serve objections to pretrial disclosures/rebuttal disclosures
7/27/2023	File Motions <i>in limine</i>
7/27/2023	Serve objections to rebuttal disclosures
8/03/2023	File Joint Pretrial Order and Pretrial Submissions (jury instructions, exhibits lists, witness lists, designations); file oppositions to motions <i>in limine</i>
8/07/2023	File Notice of Request for Daily Transcript or Real Time Reporting. If a daily transcript or real time reporting of court proceedings is requested for trial, the party or parties making said request shall file a notice with the Court and e-mail the Court Reporter, Kristie Davis at <a href="mailto:kmdavi_sc_sr@yahoo.com">kmdavi_sc_sr@yahoo.com</a> .  Deadline to meet and confer regarding remaining objections and disputes on motions <i>in limine</i>
8/18/2023	File joint notice identifying remaining objections to pretrial disclosures and disputes on motions <i>in limine</i>
8/21/2023	Final Pretrial Conference
9/11/2023	Jury Selection/Trial

Demaray's request to withdraw its motions to extend the discovery deadlines in the respective cases (Dkt. 235 in 6:20-cv-00634 and Dkt. 222 in 6:20-cv-00636) is granted.
