**NOTICE REGARDING AGREED REQUEST TO CHANGE DEADLINE

Pursuant to the Court’s Standing Order Regarding Joint or Unopposed Request to Change Deadlines dated August 11, 2021, Defendants Meta Platforms, Inc.¹ and Facebook Technologies, LLC (collectively, “Meta” or “Defendants”) hereby provide notice that the parties have agreed to an extension of time for (a) Defendants’ Opening Claim Construction brief; (b) Plaintiffs’ Responsive Claim Construction brief; (c) Defendants’ Reply brief; and (d) Plaintiffs’ Sur-Reply brief.
