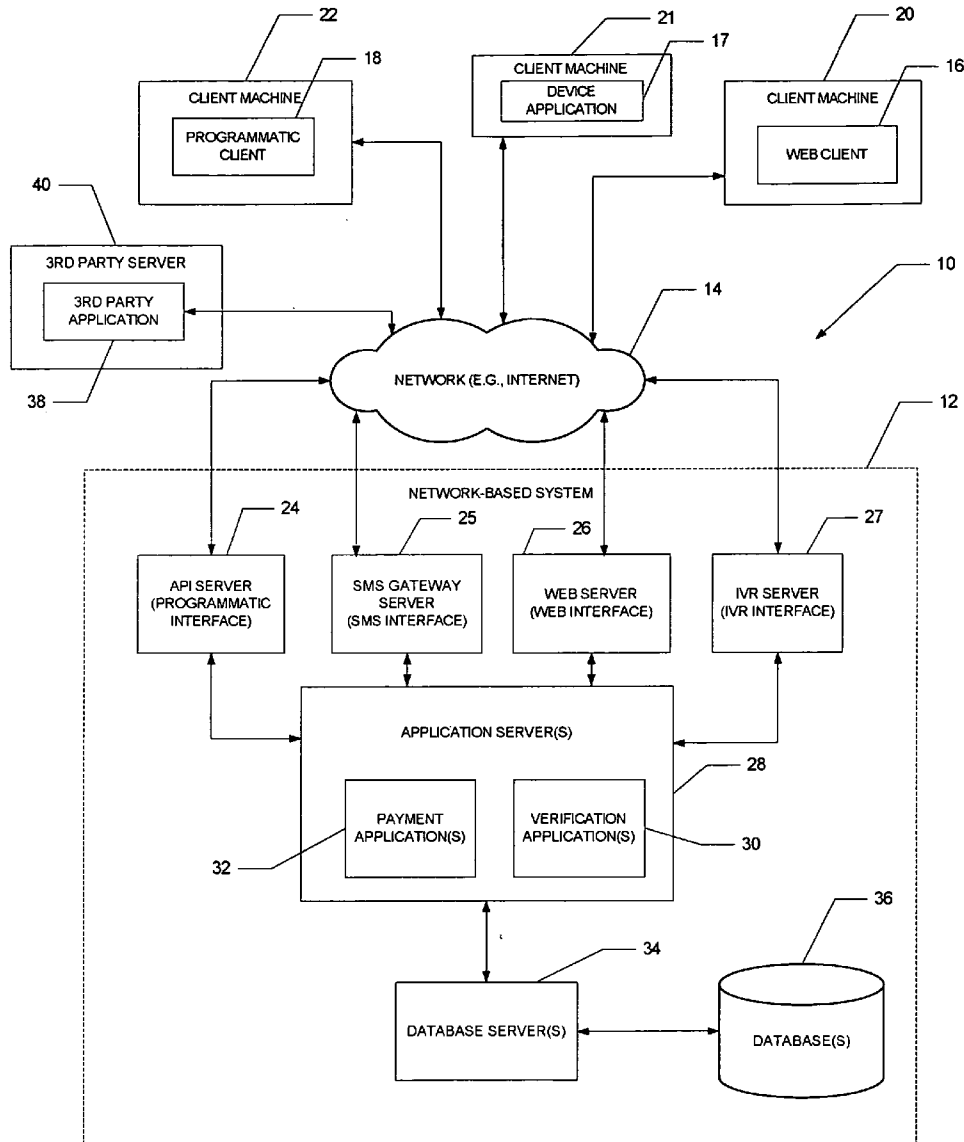

A system includes an interface to receive a request associated with a third party at a financial service provider from a network-based device via a network. 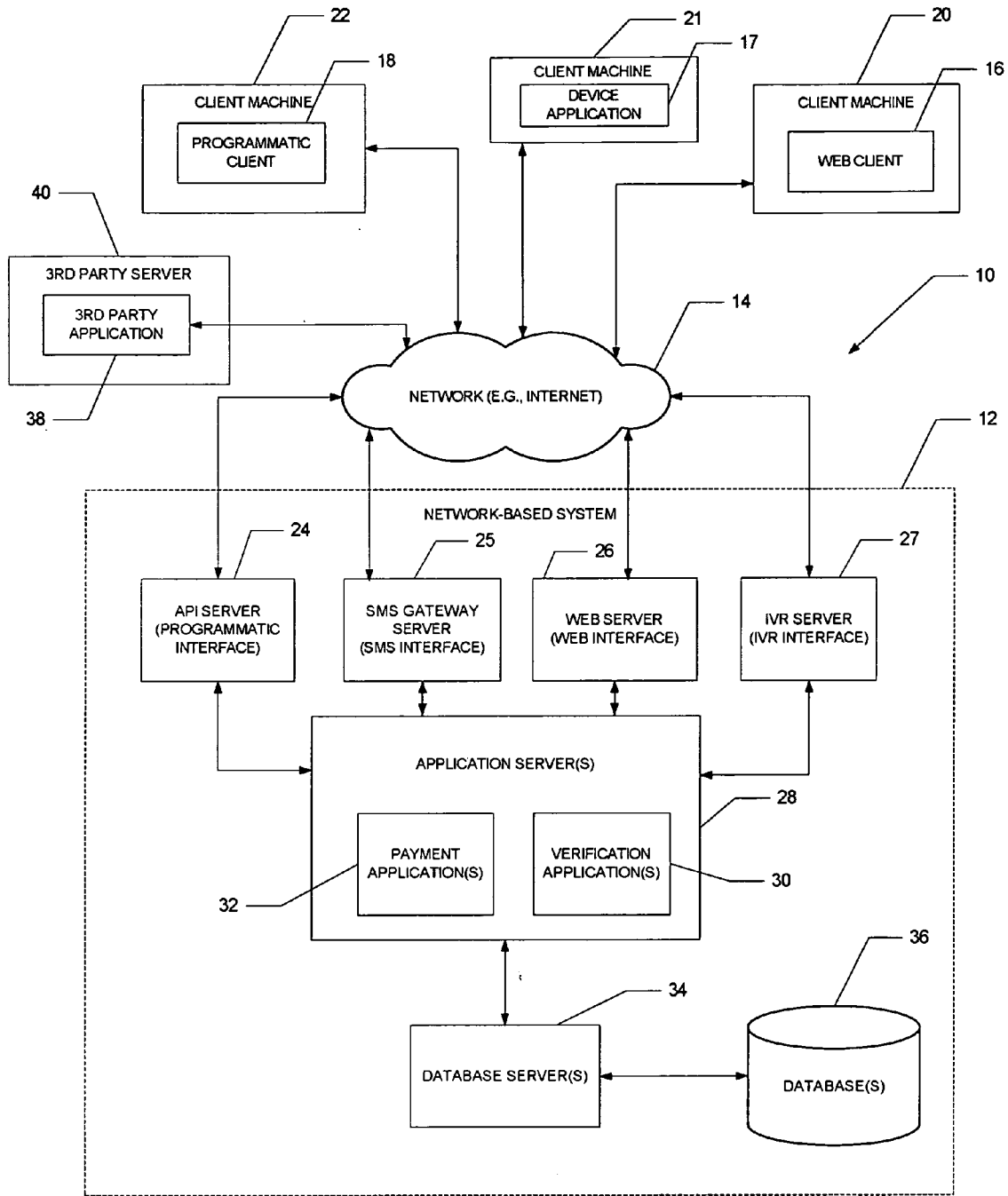

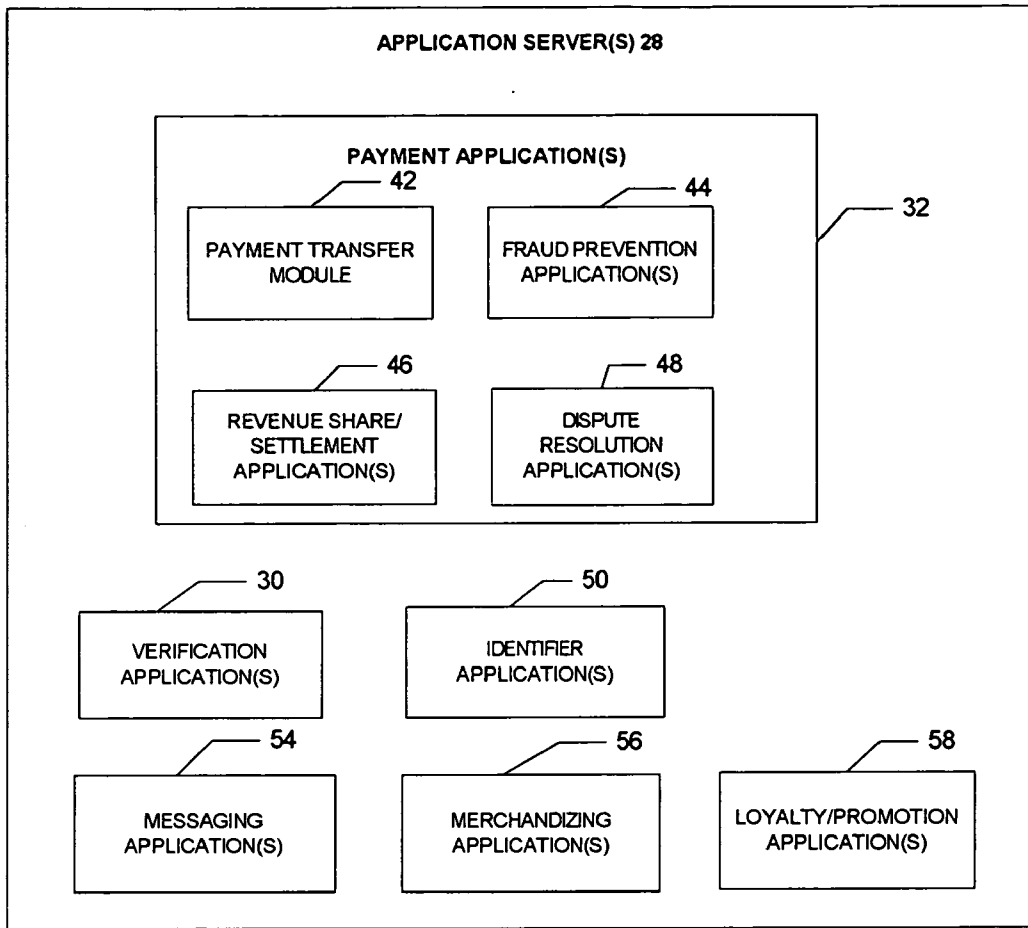

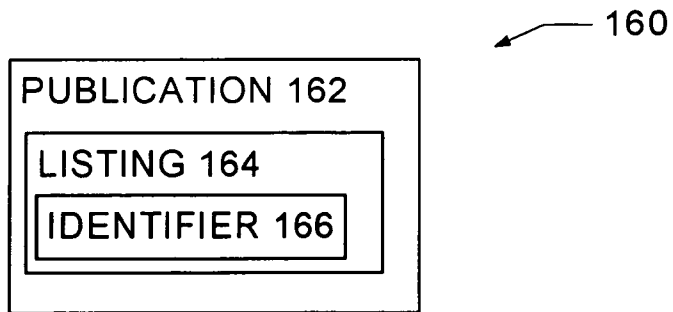

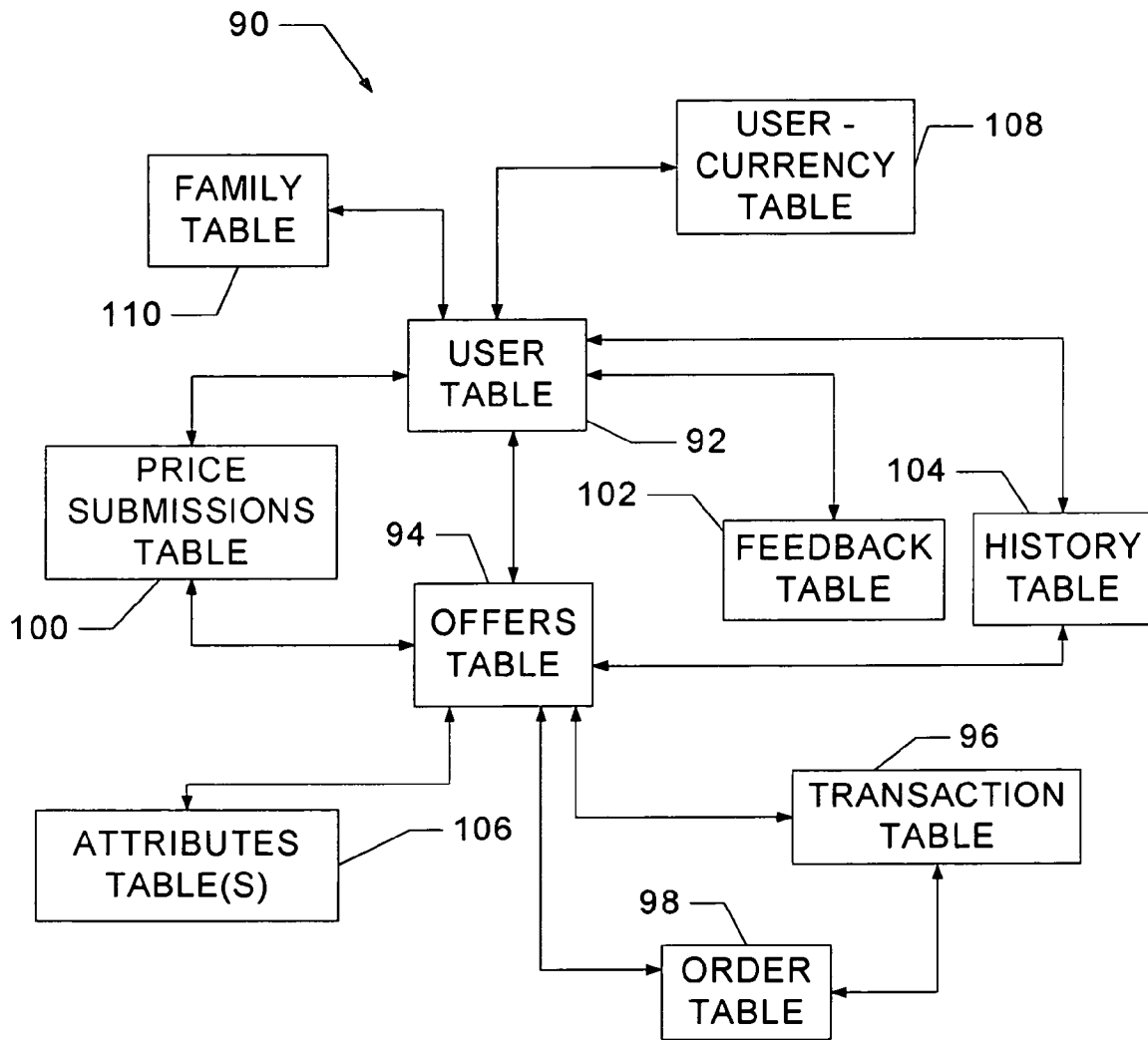
