**JOINT NOTICE OF AGREED EXTENSION  
OF AMENDED SCHEDULING ORDER DEADLINES**

Pursuant to the Court’s Standing Order Regarding Joint or Unopposed Request to Change Deadlines, Plaintiff Aire Technology Ltd. (“Aire”) and Defendant Apple Inc. (“Apple”) file this joint notice of agreed extension. On February 23, 2022, the Court entered an Amended Scheduling Order (DE 23) setting pre-trial deadlines and *Markman* hearing at 9:00 a.m. on July 18, 2022. On April 14, 2022, Apple filed a Sealed Opposed Motion to Transfer Venue Under 28 U.S.C. §1404(a), the “Motion” (DEs 24, 25). Transfer briefing on Apple’s Motion will not be completed until after the currently-scheduled *Markman* hearing. The parties conferred and agree to a three-week extension of the *Markman* hearing and to otherwise adjust the briefing schedule and related deadlines, as follows:
