11/26/2024	Deadline for the second of two meet and confer to discuss narrowing the number of claims asserted and prior art references prior art combinations at issue to triable limits. To the extent it helps the parties determine these limits, the parties are encouraged to contact the Court's Law Clerk for an estimate of the amount of trial time anticipated per side. The parties shall <b>file a Joint Report within 5 business days</b> regarding the results of the meet and confer.
12/9/2024	Dispositive motion deadline and <i>Daubert</i> motion deadline. See General Issues Note #7 regarding providing copies of the briefing to the Court and the technical adviser (if appointed).
12/19/2024	Serve Pretrial Disclosures (jury instructions, exhibits lists, witness lists, discovery and deposition designations).
1/3/2025	Serve objections to pretrial disclosures/rebuttal disclosures.
1/10/2025	Serve objections to rebuttal disclosures and File Motions in limine.
1/17/2025	File Joint Pretrial Order and Pretrial Submissions (jury instructions, exhibits lists, witness lists, discovery and deposition designations); file oppositions to motions <i>in limine</i> .
1/24/2025	File Notice of Request for Daily Transcript or Real Time Reporting. If a daily transcript or real time reporting of court proceedings is requested for trial, the party or parties making said request shall file a notice with the Court and e-mail the Court Reporter, Kristie Davis at <a href="mailto:kmdaviscsr@yahoo.com">kmdaviscsr@yahoo.com</a> . Deadline to file replies to motions <i>in limine</i> .
1/31/2025	Deadline to meet and confer regarding remaining objections and disputes on motions <i>in limine</i> .
2/7/2025	File joint notice identifying remaining objections to pretrial disclosures and disputes on motions <i>in limine</i> .
2/14/2025	Parties to jointly email the Court's law clerk to confirm their pretrial conference and trial dates.
3/4/2025	<b>Final Pretrial Conference</b> . The Court expects to set this date at the conclusion of the <i>Markman</i> Hearing.
3/17/2025	<b>Jury Selection/Trial</b> . The Court expects to set this date at the conclusion of the <i>Markman</i> Hearing.
