REGARDING VENUE BRIEFING**

Pursuant to the Court’s January 23, 2024 Standing Order Governing Proceedings (OGP) 4.4—Patent Cases § V, Plaintiff Jawbone Innovations, LLC (“Jawbone”) respectfully provides notice that, in order to accommodate document productions, the parties have agreed to extend the deadline for Jawbone’s response to Defendant Meta Platforms, Inc.’s Opposed Motion to Transfer Venue to the Northern District of California (Dkt. 28) from April 3, 2024 to April 5, 2024 and to extend the deadline for Defendant’s Reply from April 17, 2024 to April 19, 2024.
